1.	The Desludging of the existing Septic Tank	:	Done :01(one) No.
2.	Mode of disposal of sludge	:	In trenched Pit within factory compound. (Disposal of sludge should be maintained properly as per rule).
3.	Cleaning of existing soak Pit/ Chlorination Unit	:	To be maintained properly and maintained Chlorination Chamber should be operated properly at the time of maintenance work.
4.	Chlorination Unit	:	Chlorination Unit – 01(one) No. [Not functioned properly]. Treated Effluent should be disposed of properly to the drainage path to avoid contamination surroundings.
5.	a)Condition of lavatory Block b)White washing/Colour washing (As per Rule 42 of West Bengal Factory rules periodical white-washing/colour-washing of the Lavatory Block should be done at least once in every period of four months and the dates should be entered in the Register Form No.(6)	:	To be maintained properly & Unhygienic situation should be avoided near the sanitation unit. Done
6.	a) Place of drinking water.	:	To be maintained properly.
	b) Surface Drains	:	To be attended regularly as routine programme
	c) Urinals	:	To be maintained properly.
	d)Water Closets	:	To be maintained properly.
7.	Annual Return for the year	:	Submitted as per prescribed format – 2021.
8.	Next date of desludging will be on or before	:	August – 2022.

For provision for drinking water in the factory proposed construction for Septic Tank. Chlorination Unit, Soak Pit, Secondary Treatment Plant, Filter Bed etc. 04(four) sets rule (34) & rule (35) of West Bengal Factories Rule, 1958(as amended) should be followed.

OBSERVATIONS :

1. All Vent Pipe with M.P. Netted Cowl to be checked time to time avoid danger in future.
2. All Sanitary arrangement to be kept clean & maintained hygienic all time with spreading of bleaching powder regularly.
3. Septic Tank with Secondary treatment unit to be provide as per IS 2470 Part I & II – 1985 as mentioned.[i.e. vent pipe , manhole, freeboard should be provide as mentioned]. Under no circumstances should effluent from Septic tank be allowed into an open channel drain or body of water without adequate treatment [Cl. 3..3.3 IS 2470(Part – I - 1985. Proposed Secondary treatment should be construct properly as per IS 2470 (Part –II) 1985.
4. Next desludging should be done as per Sl. NO. 8 of this I.R. as per Factory Rules.
5. Surface drain should not be water logged, stagnant water should be avoided.
6. Useful arrangement should be done for the time of Pandemic situation to avoid Covid – 19.

Please take necessary action from your end before next Inspection.
